## **Deployments and Almost-Deployments**

The worried homeowner wasn't sure what he heard because the creature was hidden or had fallen down a deep hole near a shed wall. However, it sounded like a very angry, frustrated dog and that meant Animal Control needed to be involved. In response



to a call for assistance from Regional Animal Services of King County (RASKC) on **July 15**, **2011**, WASART's Duty Officer, **Gretchen McCallum**, put out a call for Field Response qualified WASART members to respond to the scene in **Tukwila**, **WA**. **Bill Daugaard** was the WASART Operations Leader on site. After examining the site with RASKC Officer Jenee Westberg and listening more closely to the animal's sounds, they determined that it was probably a raccoon and therefore a wildlife situation that did not involve WASART. The WASART members who either deployed or were placed on stand-by should more resources be needed were: **Dennis Brislawn**, **Pat Conaway**, **Joanne Craigmile-Nilsen**, **Carla Dimitriou**, **Linda McCoy**, **Shawndra Michell**, **Julia Olszewski** and **Denise Steinkerchner**, with **Lauri McBeath-Davies** and **Fred Knight** in Bellingham and **Rory Kelleher** on standby.

The next call came from Snohomish County Police Auxiliary Services Center (SNOPAC) on **July 23, 2011** at 9:45 a.m. A horse had been found trapped in mud under a log on a riverbank in **Sultan, WA**. Fire department personnel from Snohomish County Fire District #5 were on-site as was the owner and several experienced horse people. WASART's Duty Officer, **Gretchen McCallum**, discussed the situation on the phone with Fire Chief Melvin Halvorson and suggested several different options for safely rigging the horse for extraction. As a vet had been called and was on his way, Gretchen decided to wait for the vet's arrival and opinion before beginning the WASART deployment protocol. However, several senior members who were both Field Response qualified and members of WASART's Technical Rescue Team were placed on alert for a possible deployment. When Gretchen called Chief Halvorson 20 minutes later, she was advised that fire fighters had extracted the horse using a 4:1 mechanical advantage block and tackle system. The horse was unable to stand, although trying to do so, and was receiving medical attention from the vet. Congratulations were offered and no deployment was necessary as the matter had been satisfactorily resolved.



While WASART has responded to many calls for assistance for horses trapped in bogs, swamps, wells, ditches, down steep hillsides, over cliffs, etc., the call that always bothers the members the most is the call about a horse with a broken leg. Such was the call received on **August 9**, **2011** from Search and Rescue Coordinator, King County Sheriff's Deputy Kathleen Decker. A horse was injured on Tiger Mountain in

WASART's Duty Officer, **Greta Cook**, began obtaining more information preparatory to commencing the deployment protocol. However, before WASART volunteers were deployed Greta was informed that the situation had been resolved and no further resources were needed.

## Trainings, Presentations, etc.

At the request of Noah's Wish, a national animal welfare organization, Greta Cook deployed to Minot, North Dakota, on July 7, 2011, for a 10 day stint to assist in providing emergency care and sheltering to the hundreds of companion animals displaced by the flooding in that area. She returned with a wealth of hard-earned experience and knowledge that will be of great benefit to WASART's planning teams.





Supervised by members of WASART's Training Committee, 14 people attended the 2011 Emergency Shelter Training segment of WASART's training program in Enumclaw, WA on July 23-24, 2011. Four of the attendees were members of the general public and travelled from as far afield as Spokane, Pierce and Skagit Counties. The first day was mostly classroom instruction with the remainder of the day and most of the second day

being spent at a nearby farm for animal handling of livestock and companion animals and a mock shelter setup and operation drill.

The annual Dog-a-Thon on July 23, 2011 in support of the DUG-A-IHUN 2011 Tacoma-Pierce County's Humane Society raised over \$180,000 for homeless pets. For the third year in a row, WASART members staffed a booth at this hugely popular event. At the booth were The Humane Society's Walk for Homeless Pets Ritz Duchesne, Heidi Kuester, Joyce Moody, Sarah Knapp, and Yumi Taylor.



The National Night Out Against Crime held at the Maple Hills Park in Renton, WA on August 2, 2011, was attended by Gretchen McCallum and Ginger Dickson who provided information on disaster preparedness to many interested attendees. The #1 Supplies and Equipment Trailer was open for tours and was of great interest to the public as well as law

enforcement personnel also attending the event.



Yet another WASART member deployed to Minot, North Dakota. This time, **Bill Daugaard** left SeaTac Airport on **August 10, 2011** to spend a week with the American Humane Association (AHA) caring for over 300 companion animals currently sheltered in a large warehouse in Minot. One in four Minot residents have had to evacuate their homes due to flooding.

Over 65 people from many different jurisdictions and Emergency Management Departments attended the Household Pets and Service Animals Emergency Shelter Planning workshop on **August 11, 2011**. This workshop was sponsored by Pierce County Emergency Management and held at the Pierce County EOC. Representing WASART were **Marie Schimke** and **Susan Mosby**. Another regional workshop is scheduled for September 13, 2011. The aim of the workshops is to develop compre-

To celebrate the first anniversary of the Regional Animal Services of King County, **Gretchen McCallum** was invited to participate in a news conference at the Kent Animal Shelter on **August 12, 2011**. There, in the company of King County Council Executive Dow Constantine, King County Councilmembers Kathy Lambert and Joe McDermott, the mayors of the cities of Kent and Tukwila and PIMA executives, Gretchen expressed WASART's appreciation of the work of the agency and of



the mutually beneficial relationship between WASART and RASKC in meeting the needs of animals in the community. During the conference, Dow Constantine announced that the facility would henceforth be known as the 'King County Pet Adoption Center' whose "number one goal is to get pets adopted into permanent, loving homes".



## What To Do If Your Pet Is Poisoned.

First, don't panic. Take 30-60 seconds to safely collect and have at hand any material involved. If you need to take your pet to a local veterinarian, be sure to take the product's container with you. Also, collect in a sealable plastic bag any material your pet may have vomited or chewed. If you witness your pet consuming material that you suspect might



be toxic, do not hesitate to seek emergency assistance, even if you do not notice any adverse effects.

Call the Pet Poison Helpline (there is a per incident fee), the ASPCA Animal Poison Control Center at *888-426-4435* (\$65.00 consultation fee), or your local veterinarian immediately. Keep these numbers in a prominent location or in your cell phone.

Keep in mind that the prognosis is always better when a toxicity is reported *immediately*, so don't wait to see if your pet becomes symptomatic before calling for help. It's always less expensive, and safer for your pet for you to call immediately.



Finally, as a 'just in case' measure, investing in an emergency first-aid kit for your pet would helpful. WASART sells pet first aid kits for \$30.00 plus postage, stocked with items recommended by WASART's vet members. For more information on these kits contact <u>info@washingtonsart.org</u>.
